Unlike many other tools for drawing graphical diagrams, **FACTXPRESS** understands what you draw. It is an integrated graphical modeling environment in RuleXpress used to create graphical conceptual models.

Specifically it allows the user to:

- ◆ draw a box representing a term (concept),
- ◆ create lines between boxes representing an association (fact type),
- ◆ create a hierarchy of categories (taxonomy) represented by boxes,
- ◆ define a list of characteristics (attributes) for concepts in a visually compact way,
- ◆ create conceptual models that comply with the OMG standard Semantics of Business Vocabulary and Business Rules, SBVR.
